POLICY DOCUMENT

ENVIRONMENT AND ENERGY USAGE

This policy document is based on **environment and energy usage** initiatives and outlines various objectives and targets of IP (PG) College, Campus-2 as a framework for regular checking and monitoring of environmental pollution and energy usage and conservation.

Objectives of Policy:

- To secure the best practices for environmental sustainability. It reduces the possibilities of health hazards and threats for the students on the learning campus.
- To identify, quantify, describe and prioritize framework of environment sustainability in compliance with the applicable regulations, policies and standards.
- To eliminate unnecessary energy usage. Improve efficiency of energy usage.
- To provides the vital information base for overall energy conservation programme covering essentially energy utilization analysis and evaluation of energy conservation measures.
- To enhance productivity by creating incentives for greater efficiency in the use of natural resources, reducing waste and energy consumption.
- To implement clean and green initiatives and to promote environmental activities and awareness programmes inside and beyond the campus.

Targets of Policy:

- Conduct Green Audit on regular basis.
- Identify, quantify, describe and priorities a framework of environmental sustainability in compliance with the applicable regulations, policies and standards in the campus.
- Analyze environmental practices within and outside the college campus, which will have an impact on the eco-friendly ambience

Energy Audit


- Conduct energy audit on regular basis, electricity consumption and conservation in compliance with the applicable regulations, policies and standards in the campus.
- Identify the extent of energy consumption and find appropriate strategies of conservation.

Clean and Green Campus Initiatives

- Issue proper instructions to students to maintain the cleanliness of the campus.
- Display several signage boards related to the importance of clean and green environment throughout the lawn area to raise awareness about cleanliness and greenery.
- Completely ban the single use plastic products and encourage all the stakeholders to use biodegradable products as much as possible.
- Appointment of a team of full-time gardeners for the maintenance of litter free clean and green campus with adequate support, tool and techniques.
- Appointment of a team of sweepers to maintenance the cleanliness of campus.
- All floors, cabins of staff rooms with dustbins for dry wastage and separate dustbins for sanitary napkins in each girls toilets.
- Conduction of sensitization and awareness programmes for, say no to single use plastic, challenges and solutions for single use plastic waste, cleanliness, save environment etc.
- Strictly prohibited cigarettes and tobacco products in the college premises.
- Issue instructions for 'not to use cigarettes and tobaccos products' in campus to the students and the staff members .
- Displaying different signage boards to raise awareness among students at various different places in the campus.
- Communicate instructions to avoid massive wastage of papers with the students and staff members.
- Providing a bus transport facility to the students teaching staff members and non-teaching staff members, on regular basis.
- Besides this motivate students, faculty members and non-teaching staff to use public transportation/shared transportation as it can cut the level of air pollution and noise pollution in the college campus area.
- Describe a designated parking area, beyond that point, no vehicle can not come inside.
- Maximize the usage of natural resources like natural lights, natural air.
- Facilitate the collection of waste water and then water is recycled for gardening.

Beyond the Campus Environmental Promotion and Sustainability Activities

- Conduction of plantation drives, pledge, awareness talk awareness programmes, competitions, rallies, street plays, cleanliness drives and some other environmental promotion and sustainability activities outside the campus.
- Serve for community and keep track on plants those are planted in future.
- Motivate students to plant trees at their community areas and at their home with an objective of environmental conservation.
